## Terms and Conditions

The following is the standard Terms and Conditions agreement for Edward Benson Productions.

### Reservation of Time and Date

This contract constitutes an order for one Wedding Video and/or Photography service(s). Upon execution of the contract and receipt of the deposit, Edward Benson Productions will reserve the time and date agreed upon. If payment schedule is not received maintained prior to the wedding date, Edward Benson Productions may cancel the reservation without further notification to the client (verbal or otherwise).

### Environmental Elements

Edward Benson Productions is not responsible for loss of image and/or audio quality due to the restrictions at event locations. Due to the nature of live events, Edward Benson Productions cannot guarantee content or quality of the images and/or audio and will not be held liable for any production problems beyond our control, e.g. bad weather, accidents, poor acoustics/lighting, interference from guests, celebrant etc.

### Cancellation

Should a client wish to rescind the contract the deposit fee of 25% is not refundable. In the event of cancellation, if within 14 days of the event any balance excluding the final payment is due to be paid to Edward Benson Productions.

### Venue Access

It is the client's responsibility to secure access to areas for photography and/or video. Edward Benson Productions will not be responsible for coverage lost due to access restrictions.

### The Ceremony

From our experience, we have found that the ceremony runs a lot smoother if the couple communicate there Wedding Photography and or Wedding Video with the Celebrant before hand, so there are no surprises on the day.

### Payment

A deposit of 25% of the service charge is required with the signed contract. Deposit fees are non-refundable. This fee is deducted from the total package price. The balance is broken into three payments:  
Payment 1: Due at least 30 days prior to your wedding date.  
Payment 2: Due at least 14 days prior to your wedding date.  
Payment 3: Due on completion of product. (\$500)  
A \$100 late fee will be charged for late payment and will cause delays in production. Delivery or postage is not included in the package cost and will be extra.

## **Meals**

If meals are not provided for the videographer(s) and or photographer(s), the client will allow a 45 minute meal break.

## **Exclusivity**

Edward Benson Productions shall be the exclusive videographer(s) and/or photographer(s) retained by client. Family and friends are permitted to take photographs and or video as long as they do not disturb, disrupt or interfere with videographer(s) and/or photographer(s) duties.

The videographer(s) and/or photographer(s) have the right to kindly ask any person obstructing to refrain from doing so, in order for Edward Benson Productions to carry on in their duties. It is a good idea if your guests are aware of this before hand. Guests are not permitted to take photographs of poses arranged by videographer(s) and/or photographer(s). It is our duty to provide you with a unique service.

## **Delivery of Finished Product**

Completed product(s) are usually delivered to the client within 8 weeks of the event. All client-supplied material must be received at least two weeks prior to the wedding to avoid delay of the finished product(s). No DVD or images, either in progress or completed may be removed from the studio premises unless the balance has been paid in full.

## **Re-edits**

Technical errors will be corrected free of charge. Client-requested changes to their video will be charged at the prevailing daily edit rate. We will supply you with a preliminary time coded edit for you to check before the final copy/copies are made. A charge will be made to correct any errors reported after the final copy is supplied. Upon taking possession of the finished product, the client must inform Edward Benson Productions of any technical or other problems with the video and/or images within seven (7) days. After seven (7) days, if no notification has been received, the client will be deemed to be satisfied with the product(s).

## **Archiving**

Edward Benson Productions will store a copy of the completed product(s) for a minimum of one year so that you can order additional copies. We cannot, however, offer compensation for loss of the copy due to circumstances beyond our control.

## **Shipping and Delivery Policy**

Once completed, our product(s) will be mailed to the supplied address. For express (urgent) orders, please contact us by phone. Edward Benson Productions will add a postage and handling fee to all mail orders. For bulky items, which can incur additional charges, we will contact you for confirmation of additional costs.

## **Copyright**

All product(s) retain legal copyright of Edward Benson Productions at all times, as described under Australian Statutory Law. Any video and/or photography supplied to clients, either in a print form, for display on the Internet or for inclusion onto video, cannot be used for any commercial purpose. They are strictly for personal use only. Edward Benson Productions reserves the right to use your images for any form of advertising to promote their company, including but not limited to: Web based promotions, brochures, galleries and competitions.

Any material (video and or images) supplied by the client to Edward Benson Productions must be copyright free. Edward Benson Productions can not be held responsible for the inclusion of copyrighted material in the clients product(s).

## **Expenses**

Expenses incurred on the wedding day, outside of our control, (ie. Parking) paid by Edward Benson Productions will be charged to the client.
